Through their work one gave woman's unique voice and writing whereas another gave the concept of the social process of 'othering' women as the second sex in a patriarchal society. So we can say that the second wave of feminism is closely linked with the radical voices of women's rights and empowerment.

The third feminist wave, from the mid-1990s onwards, spring from the need to develop a feminist theory and politics. Emerged from the first and second wave of feminism, third wave of feminists generally consider themselves as a strong, powerful, capable and assertive social beings.

The emergence of new postcolonial world order with the information and technology, and global politics the women of this wave was opportunists and powerful.
